### **Bridgewater Sign Ordinance**

**5.4.1 Tag Sale signs are allowed by permit only. Only 3 (three) official tag sale signs furnished by the sign officer may be posted. No signs may be posted on trees, utility poles, traffic islands, or the Town Green. Signs which interfere with traffic site lines will be removed.**

### **Town of Bridgewater Zoning Regulations**

#### **Town Green Zone**

**Section 6.03.01(f): Residential tag sales and auctions, provided they are conducted solely by the residents of the dwelling at which they are conducted. Such sales and auctions shall be conducted no more than two times in any period of 365 days and shall be no longer than three days in duration.**

#### **Residential Zones**

**Section 6.04.01(d): Residential tag sales and auctions, provided they are conducted solely by the residents of the dwelling at which they are conducted. Such sales and auctions shall be conducted no more than two times in any period of 365 days and shall be no longer than three days in duration.**
