Mr. Read called the meeting to order at 7:05 pm.

**Approval of Minutes:** Mr. Brown made a motion to tentatively approve the minutes from the December 14, 2021 Board of Selectmen's meeting, seconded by Mr. Pinter. All voted in favor. Motion carries.

**Tax Refunds:** Mr. Brown made a motion to approve tax refunds as submitted by the Tax Collector (see attached), seconded by Mr. Pinter, all voted in favor. Motion carries.

**Treasurer's report:** Read for the record, see attached.

**Discussion and possible action on Grange Demolition Bids:** Mr. Brown made a motion to award the Demolition Bid to Stone Construction, seconded by Mr. Pinter, Discussion regarding staging dumpsters, etc., in the Bridgewater Bistro parking lot and along Route 133. Mr. Pinter amended the motion with the following conditions: 1. Stone

will hold the original price. 2. The State of CT Attorney General's office grants approval. All voted in favor, motion carries.

**Recognized Town Road list and spellings:** Mr. Brown made a motion to authorize the LTA (local traffic authority) to standardize the spelling of Tappen Road (from various spellings and remove Brook) and Skyline Ridge Road, seconded by Mr. Pinter, all voted in favor. Motion carries.

**Develop policy for stickers for residents using the recycling facility at the Town Garage:** Discussion, whether to have an expiration date, make them non-transferrable, one sticker per household. Tabled until Town Hall access is more amenable.
